ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a non-profit corporation under the Not for Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is QUALITY RESOURCE CENTER, INC.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

The corporation is organized to provide behavioral services, counseling and for any other purposes or activities that are lawful in the State of Florida and the United States of America for non-profit corporations.

ARTICLE IV - MEMBERSHIP

The qualifications for membership and the manner of admission shall be as set forth in the by-laws.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE XI - STOCK

This corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act and shall not have the power to issue shares of any type or class of stock but may issue membership certificates if so provided in the by-laws.

ARTICLE XII - DISSOLUTION OF CORPORATION

Any such assets not so distributed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization and organizations that the court shall deem which are organized and operated exclusively for such purposes.


