



Pursuant to the provisions of Florida Statutes 617.106 Florida Statutes, this Florida Not for Profit Corporation, adopts the following Amendment to its Articles of Incorporation:

ARTICLE III - NATURE OF BUSINESS

Currently reads: the Corporation is organized to provide behavioral services, counseling and for any other purposes or activities that are lawful in the State of Florida and the United States of America for non-profit corporations. THE AMENDMENT TO ARTICLE III – NATURE OF BUSINESS SHALL ADD THE FOLLOWING LANGUAGE:

Florida Housing defines a Non-Profit using the definition in Section 42(h)(5)(C), subsection 501(c)(3) or 501(c)(4) of the IRC and organized under Chapter 617, F.S., if a Florida Corporation, or organized under similar state law if organized in a jurisdiction other than Florida, to provide housing and other services on a not-for-profit-basis, which owns at least 50% of the ownership interest in the Development held by the general partner or managing member entity, which shall receive at least 20% of the Developer fee, and which entity is acceptable to federal and state agencies and financial institutions as a Sponsor for affordable housing, as further described in Rule 67-48.0075, F.A.C.

67-48.0075 (2) For purposes of this rule chapter, in accordance with Section 42 of the IRC, a for-profit entity wholly owned by one or more qualified non-profit organizations will constitute a Non-Profit entity. The purpose of the Non-Profit must be, in part, to foster low-income housing and such proposes must be reflected in the Articles of Incorporation of the Non-Profit entity. A Non-Profit entity shall own an interest in the Development, either directly or indirectly: shall not be affiliated with or controlled by a for-profit Corporation; and shall materially participate in the development and operation of the Development throughout the total affordability period as stated in the Land Use Restriction Agreement and the Extended Use Agreement.

The date of the adoption of the Amendment was January 10, 2017.

The effective date is January 10, 2017.

There are no members entitled to vote on the amendment. The amendment was adopted and approved by the board of directors.


