Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

ARTICLE VII

OFFICERS

B. The Board shall elect the President, the Vice President, the Secretary, and the Treasurer and as many other Vice Presidents, Assistant Secretaries, and Assistant Treasurers as the Board shall from time to time determine appropriate. Such officers shall be elected annually by the Board at the first meeting of the Board; provided, however, such officers may be removed by the Board and other persons may be elected by the Board as such officers in the manner provided in the By-laws. If an annual meeting is not held for any reason, then the current officers may continue in office as hold-over officers until such time as an election of new officers is held. The President shall be a Director of the Association, but no other officer need be a Director. The same person may hold up to two (2) three (3) offices, the duties of which are not incompatible.
