

ARTICLES OF INCORPORATION  
OF  
NORTH FLORIDA BUSINESS AVIATION ASSOCIATION, INC.

I, the undersigned, desiring to form a not for profit corporation under the laws of the State of Florida declare and certify as follows:

ARTICLE I

The name of this corporation is NORTH FLORIDA BUSINESS AVIATION ASSOCIATION, INC.

ARTICLE II

The duration of this corporation shall be perpetual unless sooner terminated. The corporation shall be deemed to commence on the date of execution and at the time of acknowledgment of these Articles, January 9, 2006.

ARTICLE III

The corporation is organized for the purposes of promoting and enhancing the growth of business aviation in the North Florida region and of furthering the safety of flight and aviation operations in the region.

ARTICLE IV

The street address of this corporation's initial registered office is 100C Wharfside Way, Jacksonville, Florida 32207, and the name of the

#### ARTICLE V

Upon dissolution of the corporation, the assets of the corporation shall be distributed in accordance with provisions set forth in the By-Laws.


ARTICLE IX


