ARTICLES OF INCORPORATION OF

THE POINT AT PUNTA GORDA CONDOMINIUM ASSOCIATION: INC.
A FLORIDA CORPORATION NOT FOR PROFITIALLAMASSEE, FLORIDA

THE UNDERSIGNED, for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is: THE POINT AT PUNTA GORDA CONDOMINIUM ASSOCIATION, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida. If the Corporation is dissolved, the property consisting of the common surface water management system shall be conveyed to an appropriate agency of local government, and if not accepted, to a similar not-for-profit corporation.

ARTICLE III

PURPOSES

This corporation is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act") for the operation of a condominium located in Charlotte County, Florida, and known as The Point at Punta Gorda, a Condominium.

ARTICLE IV

AUTHORITY

This corporation shall have, in addition to all corporate powers granted corporations not-for-profit under the Florida Statutes (except as may be limited or otherwise provided by these Articles), the following powers and authority:

A. To acquire, own, hold, improve, manage, operate, maintain, repair, replace, convey, sell, lease, transfer, assign and otherwise dispose of property of any nature whatsoever, real, personal or mixed, tangible or intangible, in connection with this Corporation's affairs.

- B. From time to time adopt, alter, amend, rescind and enforce reasonable rules and regulations governing the use of the Condominium Property consistent with the rights and duties established by the Declaration of Condominium, these Articles and the Bylaws of the Corporation.
- C. To levy and enforce assessments in accordance with the provisions of the Declaration of Condominium and Chapter 718, Florida Statutes.
- D. To own, acquire, operate and maintain the common Surface Water Management System (as defined in the Declaration of Condominium), and to contract for services to provide for operation and maintenance thereof.
- E. To employ such persons or contract with such independent contractors or agents as shall be reasonably required or appropriate, in the reasonable judgment of the Board of Directors, in order for the Association to carry out, perform and discharge all or any part of its duties, obligations and responsibilities pursuant to the Declaration of Condominium and these Articles.

ARTICLE V

MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE VI

ADDRESS OF THE CORPORATION

The street address of the principal office of the corporation is 450 SW 88th Terrace, Pembroke Pines, Florida 33025, and the mailing address is 450 SW 88th Terrace, Pembroke Pines, Florida 33025.

ARTICLE VII
