The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation in accordance with the laws of the State of Florida for philanthropic purposes in accordance with Florida Statutes Section 617, to help to provide food service needs to underserved individuals and families which are not otherwise provided through, related agencies, county, state or government programs.

ARTICLE I. - NAME

The name of this corporation is THE COMMUNITY BUTTERFLY FOOD BANK, INC.

ARTICLE II. - ADDRESS

ARTICLE III - NATURE OF CORPORATION

The general nature of the business to be rendered by this corporation to help to provide food service need throughout the community by

This corporation shall have perpetual existence.

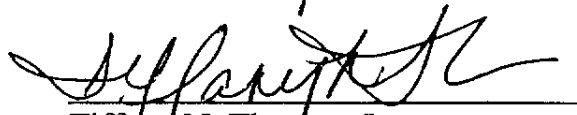
