**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a Florida non-stock corporation under Chapter 617, F.S. (Not for Profit), hereby adopt the following Articles of Incorporation:

**ARTICLE I – NAME**

The name of the corporation shall be New Start Marketplace Ministry, Inc.

**ARTICLE II – PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 99 Whispering Pines Court, Santa Rosa Beach, Florida 32459.

**ARTICLE III – PURPOSE**

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions or organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV – MANNER OF ELECTION**

The Trustees of the Corporation shall act in the capacity of Directors of the Corporation and shall be members of the Corporation. The initial Trustees shall be the persons indicated below. Thereafter, the Trustees shall be appointed in accordance with the provisions of the By-laws of the Corporation. The number of Trustees may be fixed by By-law, but shall not be less than three (3) or more than twelve (12).

**ARTICLE V – INITIAL DIRECTORS OR TRUSTEES**

#### ARTICLE VI – REGISTERED AGENT

#### ARTICLE VII – INCORPORATOR

#### ARTICLE VIII – INUREMENT OF INCOME

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### ARTICLE IX – MEMBERSHIP

The corporation shall have members. The By-laws of the corporation shall set forth the requirements for obtaining, maintaining and termination of membership in the corporation.

ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended in the manner authorized by law at the time of such amendment.


ARTICLE XI - DISSOLUTION OF ASSETS


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes with in the meaning of section 50(c)(3) of the Internal Revenue Code, or the corresponding section any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively or such purposes.

ARTICLE XII - EFFECTIVE DATE

The effective date for incorporation of New Start Marketplace Ministry, Inc. shall be considered to be December 23, 2005.
