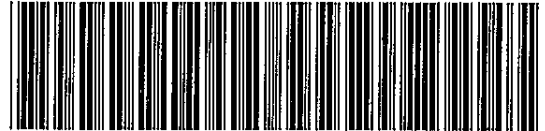

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I – NAME

The name of the Corporation shall be: **All About Youth, Inc**

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is exclusively for charitable, educational, scientific, literary and recreational purposes. Specifically, the corporation provides academic, recreational, and child care services to youth of all ages. Our mission is to provide healthy and productive activities to keep our young people off the streets, eliminating potential criminal activity, assist them in preparing for their future, and provide care for children in an effort for parents to be gainfully employed.

ARTICLE IV – TERM

The Corporation shall have perpetual existence.

ARTICLE V – LIMITATIONS

In the event of the dissolution of the corporation, no part of the assets or income shall inure to the benefit any member, director, officer or any other private individual. The distribution of assets, after all debts and liabilities of the corporation has been met, shall be disbursed to a non-profit charity foundation, fund or corporation as determined by the Board of Directors.

ARTICLE VI – MANNER OF ELECTION

The office of the Board of Directors will be held for three years or until successors are appointed or elected and qualified. Should an office become vacant by resignation, death or due to inappropriate conduct, a replacement will be appointed by a majority vote of the remaining Board Members.
