ARTICLE ONE Name

The name of the corporation is Marco Police Foundation Scholarship Fund, Inc.

ARTICLE TWO **Principal Office and Address**

The mailing address of the corporation is 1083 North Collier Blvd., #123, Marco Island, Florida 34145. The street address of the principal office of the corporation is 124 Shorecrest Court, Marco Island, Florida, 34145.

ARTICLE THREE Duration

The term of the existence of the corporation is perpetual.

ARTICLE FOUR Purposes

As a limitation, the purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any United States Internal Revenue Law.
