**Articles of Incorporation  
of  
Lady Aggies Booster Club, Inc.  
A Florida Not For Profit Corporation**

The undersigned acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopts the following articles of incorporation for such corporation:

**Article 1. Name**

The name of the corporation is "Lady Aggies Booster Club, Inc."

**Article 2. Principal Office and Address**

The address of the principal office of the corporation is 1771 Tate Road, Cantonment, Florida 32533, and the mailing address of the corporation is 10250 N. Palafox St., Pensacola, Florida 32534.

**Article 3. Duration**

The term of existence of the corporation is perpetual.

**Article 4. Purpose**

4.01. The corporation is not organized for pecuniary profit or financial gain, and no part of the corporation's assets or income shall inure to the benefit of any director, officer, or member of the corporation except as may be authorized by the corporation's board of directors in accordance with the terms and provisions of the corporation's bylaws for compensation of directors, officers, or members of the corporation for rendition of services by such individual to the corporation.

4.02. The corporation is organized to be a not-for-profit corporation under Chapter 617, Florida Statutes, in order to promote and support educational and athletic interests associated with the young women's soccer program at Tate High School, Cantonment, Florida.

4.03. Upon the dissolution of the corporation its board of directors shall adopt a plan of distribution that satisfies the requirements of Section 617.1406(3), Florida Statutes, and any other applicable law.

**Article 5. Registered Office and Agent**

The initial registered office of the corporation shall be located at 10250 North Palafox Street, Pensacola, Florida 32534. The initial registered agent of the corporation at that address shall be Diane Fitzpatrick.

**Article 6. Directors**

The method of election of the directors of the corporation is set forth in the corporation's bylaws. The names and addresses of the initial directors that shall hold office until their
