The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation pursuant to Section 617 of the Not for Profit Corporation Laws of the State of Florida, do hereby make, subscribe, and acknowledge these Articles of Incorporation, as follows:

ARTICLE I

NAME

The name of the corporation shall be the Parenting Upgrade Center, Inc.

ARTICLE II

DURATION

The Parenting Upgrade Center, Inc shall commence corporate existence upon the filing of these Articles by the Florida Department of State and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

PRINCIPAL PLACE

The place in this state where the principal office of the Parenting Upgrade Center, Inc is to be located is the City of Tallahassee, Leon County. The principle place of business and mailing address of the corporation shall be:

ARTICLE IV

PURPOSE AND GENERAL POWERS

The Parenting Upgrade Center is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future tax code, and not for pecuniary profit. The Parenting Upgrade Center, Inc's purposes shall include, but are not limited to, providing training in parenting, marriage &

family relationships, personal & professional skills enhancements, and other self-help and crisis-intervention courses, and training for psychological well-being and growth, for the purpose of reducing violence in the communities the Parenting Upgrade Center, Inc serves. The Parenting Upgrade Center, Inc is created pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617 of the Florida Statutes and may exercise all powers conferred on a corporation organized under the Florida Not For Profit Corporation Act as currently in effect and as it may be amended, and all such other powers as are permitted by applicable law, except as restricted by Article XI herein.

ARTICLE V

ELECTION OF DIRECTORS

The manner by which directors are elected will be stated in the bylaws.

ARTICLE VII

BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors.

ARTICLE VIII

AMENDMENT

The Parenting Upgrade Center reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto.

ARTICLE IX

INITIAL REGISTERED AGENT

ARTICLE XI

EARNINGS AND LIMITATIONS OF ACTIVITIES

Section 1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

Section 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of or in opposition to any candidate for public office.

Section 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a

corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE XII

DISSOLUTION OF ASSETS

Upon the dissolution of the Parenting Upgrade Center, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the Parenting Upgrade Center is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for one or more of the purposes of the Parenting Upgrade Center.
