TO: State Corporation Commission:

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do here certify:

__ Article I: The name of the Corporation shall be Victorious Life Academy Parent Teacher Fellowship, Inc.

Article II: The place in this state where the principal office of the Corporation is to be located in the City of Wesley Chapel, Pasco County.

Mailing address: 5450 Bruce B. Downs Box # 378 Wesley Chapel, FL 33543.

Article III: Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: Nominations

The nomination committee, formed in March shall be comprised of five active members, three from the PTF governing board and two from the general membership. The parliamentarian shall serve as chairperson of this committee.

No person sitting on the nominations committee may seek elective office. The parliamentarian serves on this committee in a non-voting capacity. The president shall not serve as a member of this committee.

If the parliamentarian chooses to run for an elected position, he/she will appoint a chairperson to conduct the nominations and elections.

The nominations committee shall prepare a slate of nominees for each office. The committee shall secure the consent of the nominees and shall present the slate of nominees to the PTF governing board.

Those persons seeking the office of president and vice president of fund raising must have either served on the board for one year prior to seeking office, have been an active participant in the PTF projects/programs, or have recommendations from two VLA faculty or governing board members.

Elections

Elections of officers shall take place at the May meeting. Elections shall proceed by ballot if there is more than one candidate for any office. Elections may be

made by voice vote if there is only one candidate for each office. A majority of those present is necessary to elect.

The nominations committee shall prepare the ballot and conduct the election.

A vacancy occurring in any elective position shall be filled by a majority vote of the PTF governing board once a quorum has been determined. If a vacancy occurs in the office of the president, the vice president of fund raising shall assume the duties of that office.

A person shall not be eligible to serve more than two consecutive terms in the same office. A person having more than half a term shall be credited with having served that term.
