



ARTICLES OF INCORPORATION

WE, the undersigned, hereby associate ourselves for the purpose of becoming a not-for-profit Corporation under the laws of the State of Florida and are therefore bound by State Statutes regulating information, liability, rights, privileges and immunities of a not-for-profit Corporation.

ARTICLE I  
Name of Corporation

The name of this corporation is M.A.C. HELP CENTER FOR THE POOR INC.

ARTICLE II  
Purpose

This corporation is organized to provide assistance in the form of shelter, food, and other support services to the poor without regard to color, race and religion. The operating funds may come from different sources: individuals, government, general public and other not-for profit organizations.

In the pursuit of this goal, the Corporation can acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise. It can also mortgage, lease, hypothecate, convey, exchange and dispose of lands and chattels. It may enter any transactions deemed lawful authorized by the Board of Directors.

ARTICLE III  
Corporate existence

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.

ARTICLE IV  
Principal Place of Business

The initial place of business is 6240 Dodd Rd, Greenacres, Florida 33463. The mailing address is the same as the place of business. The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.

## ARTICLE V

### Dissolution

Upon dissolution, the remaining or residual assets of M.A.C. HELP CENTER FOR THE POOR shall be transferred to Morija Alliance Church located in Greenacres, Florida 6240 Dodd Rd zip code 33463.

## ARTICLE VI

### Prohibited Activities

Notwithstanding any other provisions of these articles, this corporation shall carry only activities permitted to be carried on by (a) a corporation exempt from Federal Tax under Section 501 (c) (3) of the internal revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation's contribution which are deductible under section 170 (c) (2) of the Internal revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue law.

## ARTICLE VII

### Initial Board of Directors

Initially, this corporation shall have five directors. The number of directors may increase depending on business needs, but may never be less than one. The name and address of the initial directors are as follows:



The President, with the approval of the Board of Directors, can enter into contracts for the company. He/She can execute and deliver any commercial instruments in the name of and on behalf of the company.


**ARTICLE X**
