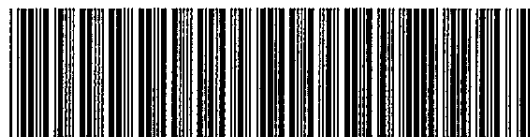

DIRECTORS






