ARTICLE I NAME

No substantial part of its activities will be carrying out propaganda or otherwise attempting to influence legislation. The corporation will not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Upon dissolution, all assets of the corporation will be distributed to organizations exempt under Internal Revenue Code section 501 (c)(3). Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IX DISSOLUTION

In the event of a dissolution of said corporation, the Directors shall Arrange for the payment of all debts and dispose of the corporation's remaining assets to credible Islamic Organization or organizations within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or shall be distributed to the Federal Government, or to a State or local Government, for a public purpose.
