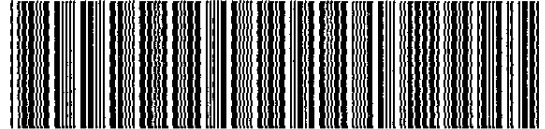

Articles of Incorporation (A Corporation Not For Profit)

We, the undersigned with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of chapter 617 of the Florida Statutes do agree to the following:

Article I Name

Section 1. Jacksonville, Duval, Florida Chapter of the Southern Christian Leadership Conference, Inc.

Article II. Address

1346 North Davis Street, Jacksonville, Florida 32209

Article III. Purpose

The general nature of the objectives and purpose of this Corporation shall be:

1. To enhance the opportunities of education, training, employment, housing, social and civic growth for anyone desirous of the available services through this Corporation.
2. To establish programs and work with other similar groups or an agencies to provide worthwhile human development activity that will improve the quality of life for the people of Jacksonville.
3. To encourage and expand opportunities for all residents of the community and the State of Florida by providing technical assistance to community based organizations, municipalities, agencies, school systems, or groups to develop a base from which people of all races can communicate their problems and/or community concerns.
4. To provide a counseling program for youth, specifically, those who are adjudged delinquent by the Courts, and those who are classified as "disruptive youth" by the public school system throughout the State of Florida.
5. Environmental & Ecological issues effecting the well being of the community.

Article IV. Membership

Section 1. The membership of this Corporation shall be unlimited as to the number of members.

Section 2. Any natural person that consents and adheres to the policies, principles and goals of the nonviolent philosophy as set forth in the National Charter and the By-LAWS of the Local Chapter may become a member.

Section 3. By paying annual membership fees in advance as prescribed by the National Office, national membership is included with the membership of the Local Chapter.

Article VII. Officers

Section 1. The officers of this Corporation shall be a President, Vice President, Secretary, Treasurer, and such other appointed officers as may be provided in the By-Laws.

Section 3. The officers shall be elected as provided for in the By-Laws.

Article VIII. Board of Directors

Section 1. The business affairs of this Corporation shall be managed by the Board of Directors. This Corporation shall have seven (7) directors initially. The number of directors may be increased or decreased from time to time, subject to the rules of the By-Laws, but shall never be less than three (3).

Section 2. The Board of Directors shall be members of the Corporation.

Section 3. Members of the Board of Directors shall be elected and hold office in accordance with the By-Laws.

Article IX. By-Laws

Section 1. The membership of this Corporation may provide such By-Laws for the purposes of conducting its business, and to carry out the general purposes of this Corporation as deemed necessary from time to time.

Article X. Amendments

Section 1. Upon proper notice, the By-Laws may be amended, altered or redeclined by a two-thirds majority vote by those members of the Corporation presents at any regular meeting or a special meeting called for this purpose. Otherwise, it takes a majority of the entire registered membership to amend any bylaws.

Article XI. Powers

Section 1. In order to promote the purpose of this Corporation, and to provide services as set forth in the general purposes, the Corporation may acquire funds through grants, gifts, bequest, or loans.

Section 2. This Corporation may acquire property by grant, gift, purchase, bequest or loan, and the Corporation may hold and dispose of such property as the Corporation shall require for the benefit of its general purposes and not for any pecuniary profits.

Section 3. To acquire by purchase, or lease, or lease or on conditional sale or chattel mortgage or otherwise, any personal property necessary or proper or useful in the equipment of this Corporation to promote the general purposes of the Corporation.

Section 4. Any profit derived from such sales as described in Section 3 of these Articles of Incorporation shall not be used to the personal gain of any member of the Corporation, but shall be used to promote the general purposes of the Corporation in its operation.

Section 5. No salary or other compensation shall be paid to any officer or director of the Corporation for services rendered as such officer or director unless and until the same shall have been approved in writing by an affirmative vote taken at a duly held meeting of the membership, and shall have an affirmative vote of the Quorum.

Article XII. Non-Profit Status

No part of the net earnings, if any, of this Corporation shall inure the benefit of any individual or member. If in the event of dissolution of this Corporation, no person; firm, or corporation shall receive any dividends or profits from the undertaking of this Corporation. Upon dissolution of this Corporation, all of its assets remaining after payment of all debts, and other expenses of such dissolution shall have been distributed to organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code, or to the Federal Government, or to a state or local governmental agency, or a public purpose, and none of these assets will be distributed to any member, officer, or director of this Corporation.

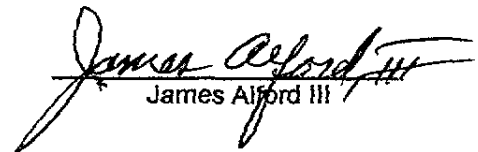
