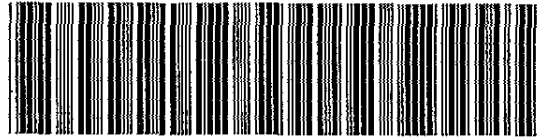

**ARTICLES OF INCORPORATION FOR NONPROFIT  
ORGANIZATION**

Pursuant to Florida Statutes Chapter 617.0202, the undersigned subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I Name**

The name of the corporation is **Word of Faith Fellowship Center, Inc.**

**ARTICLE II Address**

The principle place of business and the mailing address of this corporation shall be:

**ARTICLE III General Purpose**

The purpose for which this corporation is organized is exclusively for religious activities as is defined under the Internal Revenue Code, Section 501C(3); to promote Christ and Christian ethics, to teach practical Christian living, to feed the homeless, engage families in healthy living practices, to promote Christ in communities and on the radio, television and newsprint and all such things as is lawful to further such purposes for Christ. Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501C(3) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of section 501C(3) purposes.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal

income tax under section 501C(3) of the Internal Revenue Code, and the Florida Not For Profit Corporation Act.

### ARTICLE VIII Amendments

This corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation by the affirmative vote of a majority of the Directors present at a meeting of the Board of Directors.
