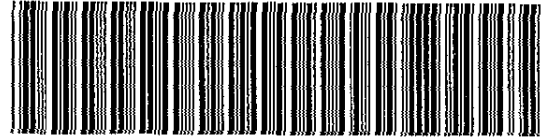

ARTICLES OF INCORPORATION
of

Pursuant to Chapter 617, Florida Statutes

ARTICLE I
NAME
