AMENDMENT TO THE ARTICLES OF INCORPORATION OF COPPERSTONE TOWNHOME HOMEOWNERS ASSOCIATION, INC.

Amendment to the Articles of Incorporation of Copperstone Townhome Homeowners Townhome Association, Inc., as originally recorded as Exhibit "B" to the Declaration of Covenants, Conditions and Restrictions, at Official Records Book 2211, Page 3361, et. seq., of the Public Records of Manatee County, Florida, and as may have been amended from time to time thereafter:

<u>ARTICLE VI – BOARD OF DIRECTORS</u>

The affairs of this Neighborhood Association shall be managed by a Board of Directors, which so long as Class B membership exists, shall consist of three (3) directors, and thereafter shall consist of not less than three (3) five (5) nor more than nine (9) directors. Directors shall be members of the Neighborhood Association; provided, however, that so long as Class B membership shall exist, directors need not be members of the Neighborhood Association. The names and addresses of the persons who are to act in the capacity of directors until their successors are elected and qualified, unless they sooner shall die, resign or be removed, are:

..

The initial Board of Directors herein designated shall serve until Class B membership has ceased and been converted to Class A membership until the first annual membership meeting thereafter, at which time the members shall elect three (3) directors. Directors elected at the first such annual membership meeting and thereafter shall serve for a period of one year, and until their successors have been duly elected and qualified. So long as Class B membership shall exist, any member of the Board of Directors may be removed, with or without cause, but only by the Class B member, and any vacancies occurring on the Board of Directors shall only be filled by appointment by the Class B member.

Beginning with the first election following the recording of this Amendment, the Board of Directors shall be elected for three (3) year staggered terms, except to initially establish them. To initially establish the system of staggered terms, two (2) directors shall be elected to serve three (3) year terms, two (2) directors shall serve two (2) year terms, and one (1) director shall be elected to serve a one (1) year term. The two (2) candidates receiving the greatest number of votes shall take three (3) year terms, the two (2) candidates receiving the next highest number of votes will serve two (2) year terms, and the candidate receiving the least number of votes will take a one (1) year term. At all elections thereafter, directors will be elected for three (3) year terms. The minutes of the meeting at which the election is held shall designate the length of term for which each successful candidate has been elected.
