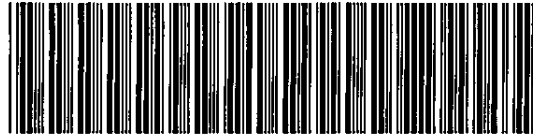

**Article III**  
**Purpose**

We are an organization that provides an opportunity for individuals, men and women, in a group setting to read the Word of God, so they may be edified in their knowledge pertaining to the information that they are reading.

We also encourage individuals in the areas of self-esteem, faith, hope, and patience that deal with abilities according to the Word of God. It also allows participants to be educated in the reading ability to understand terms, definitions, and phrases.

We will provide support as a group/organization based on the Word of God that allows an individual to cope, deal, and/or relate to the active process of life; in other words "Just Living", that we believe comes from an active participation in reading the Word of God. We believe this will allow individuals in there decision making process, as well as in the active engage process of life. It will also increase the level of interest towards inquiring the knowledge that God has intended for us all to have.

Long term, we will provide a pace where participants may come and fellowship for resources that would direct them in the direction of appropriate churches, support groups, and programs that is most suitable for there needs and concerns.

- We also provide resource information through working relationships with community base programs, and local churches in the area. As well as providing these reading sessions to offenders and ex-offenders to assist in their after care process.

The overall purpose is to increase the desire to read the Word of God so that life management and decision making skills are a little less difficult.

**Article IV**

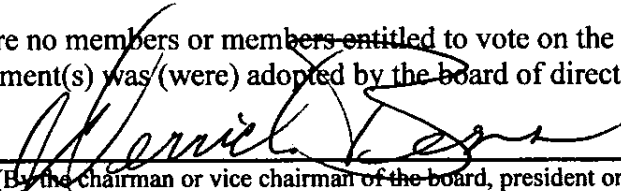
