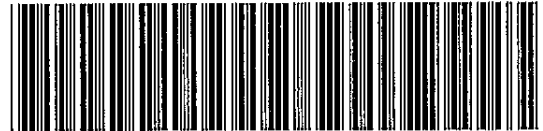

### **Article III Purpose**

The purpose for which the corporation is organized is:

#### **Section 1.**

In compliance with the laws relating to non-profit corporations as set forth in Chapter 617 of the Florida Statutes currently in force and as amended from time to time. No assets or income of this corporation shall be distributed to or insure the benefit of the Directors or Officers.

#### **Section 2.**

To organize and promote religious, social, recreational and similar non-profit activities for its members. The corporation shall promote employee participation to develop fellowship and teamwork in a corporate, charitable community and recreational activities which promote individual morals, fitness and well being.

#### **Section 3.**

To operate exclusively in any other manner for such charitable purposes as will qualify if as an exempt organization under section 501(c) (3) of the Internal Revenue Code of 1986 as amended or under any corresponding provisions of any subsequent Federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended including private foundations and private operating foundations.

### **Article IV Manner of Election**

The manner in which the directors are elected or appointed:

The selections of the initial Board of Directors shall be made by the President/Senior Pastor of the Corporation. Their initial term of office shall be one (1) year. They may at the discretion of the President/Senior Pastor serve an additional two years. All subsequent Directors shall be elected for a term of two (2) years. Directors are limited to serving two consecutive terms, only the President/Senior Pastor is empowered to make exceptions to the two consecutive term rule. Elections shall be at the annual meeting of the Board. Each Director shall serve until a successor has been elected and qualified. If any such annual meeting is not held or The Directors are not elected there at, The Directors may be elected at any special meeting of Directors held for that purpose. The Board shall fill any vacancies that may occur.
