ARTICLES OF INCORPORATION

OF

WE, THE UNDERSIGNED, LaVata Garmon, President and Brenda Brown, Secretary...for the purpose of forming a corporation non-profit under the laws of the State of Florida, hereby, adopt the following Articles of Incorporation:

ARTICLE I

NAME

Section 1.1. Name: The name of the corporation is **THE MISSION..."A House of Prayer & Refuge" Ministries, Inc.**

Section 1.2. Address of Principal Office: The address of the Principal office of the corporation is: 1075 Walnut Street, Jacksonville, Florida 32209.

Section 1.3. Mailing Address: The mailing address of the corporation is: 1075 Walnut Street, Jacksonville, Florida 32209.

ARTICLE II

PURPOSES

Section 2.1. Purposes: The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the prevention of cruelty to children, the prevention of cruelty to the elderly, promotion of amateur sports competition (excluding the provision of athletic facilities or equipment), and the making of distributions to organizations that qualify as exempt organizations under Section 501 (C) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically, this corporation is organized for the purpose of establishing churches and the ordaining of Ministers to serve said churches.

ARTICLE III

BOARD OF DIRECTORS

Section 3.1. Election: Directors shall be elected in the manner set forth in the Bylaws of the Corporation.

Section 3.2. **Number:** This Corporation shall have (five) 5 Directors initially. The number of Directors may be increased or reduced from time to time, as provided in the Bylaws of the Corporation; however, the corporation shall at all times have at least (five) 5 Directors. ARTICLE IV

LIMITATIONS

Section 4.1. **Limitations on Actions:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any member, director, officer or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to confer benefits on its members in conformity with the purposed set forth in Section 2.1 of these Articles. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V
