Article VIII.

CHARITABLE ORGANISATIONS PROVISIONS

Notwithstanding any powers granted to the Corporation by its Articles, By Laws or by the Laws of the State of Florida, the following limitations of power shall apply:

- a. The Corporation is organised exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organisations that qualify as exempt organisations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code").
- b. No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorised and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of this document, the organisation shall not carry on any other activities not permitted to be carried on (i) by an organisation exempt from federal income tax under Code Section 501(c)(3); or (ii) by an organisation contributions to which are deductible under Code Section 170(c)(2).
- c. Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Code

Section 501(c)(3), or shall be distributed to the federal government, or a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by the court having jurisdiction over the Corporation, exclusively for such purposes or to such organisation or organisations, as said court shall determine, which are organised and operated exclusively for such purposes.
