

**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of Florida Statutes Chapter 617, the undersigned, acts as incorporator and adopts the following articles of incorporation for the purpose of organizing and forming such corporation (the "Corporation") as follows:

**ARTICLE I
Name**

The name of the Corporation is:

**ARTICLE II
Principal Office**

Purpose**

The purpose for which the Corporation is organized is: religious, charitable and educational purposes.

**ARTICLE IV

The Corporation shall indemnify its directors, to the fullest extent permitted by law.


ARTICLE XII


