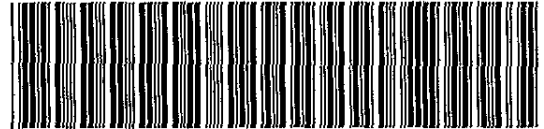

**ARTICLES OF INCORPORATION**  
**In Compliance with Chapter 617, F.S., (Not for Profit)**

**Articles of Incorporation** of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**ARTICLE I: NAME**

The name of the corporation shall be: Vanderbilt Christian College, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The place in the State of Florida where the principle office of the Corporation is to be located is in the City of Pompano Beach, Broward County. The principal place of business and mailing address of this corporation shall be: Mailing Address: Vanderbilt Christian College, Inc. 2508 Bay Drive #303 Pompano Beach, Florida 33062

**ARTICLE III: PURPOSE**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV: MANNER OF ELECTION**

The manner in which the directors are elected or appointed: The board members are appointed based on their interest in the organization's purpose, willingness to work in a group, ability to make financial contributions to the organization, and have expertise in an area that will benefit the organization.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or

otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VI: INITIAL REGISTERED AGENT AND STREET ADDRESS**
