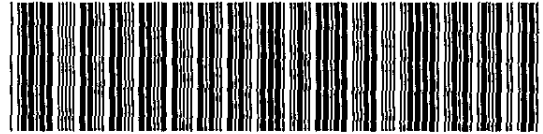

ARTICLE ELEVEN

ARTICLE THIRTEEN

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for political office.


ARTICLE FOURTEEN


ARTICLE FIFTEEN
