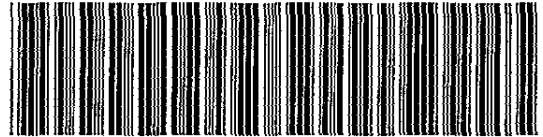

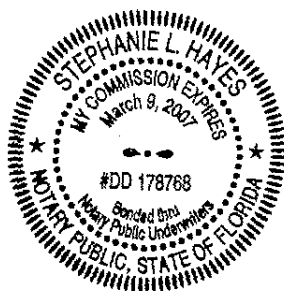



Amendment(s) to the Article of Incorporation may be proposed by a majority vote of the Board of Directors at a meeting, and shall be adopted by a two-third (2/3) majority vote of the active members good standing PRESENT AT ANY MEETING, PROVIDED THAT THE PURPOSE OF THE MEETING AND THE AMENDMENTS TO THE Articles of Incorporation to be voted on have been plainly stated in the notice of the meeting mailed to the membership at least seven (7) days prior to the time of such meeting.

ARTICLE XIV

In the event of the dissolution of the corporation, no member, director, or officer shall be entitled to or receive any distribution or division of its remaining property or its proceeds, and the balance of all money and other property payment of all debts and obligations of the corporation, shall be awarded to the designated non profit organizations.
