Articles of incorporation of the undersigned, the majority of whom are citizens of the United States, desiring to form a Non Profit Corporation under the Non-Profit law of Florida do hereby certify:

The name of the corporation shall be RAJAH'S RESCUE SANCTUARY & FOSTER INC.

The place in this state where the principle office of the corporation is to be located is the city of Mayo and the county of Lafayette.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (C)(3) of the Internal Revenue Code, or the corresponding section of any future federal code

The names and the addresses of the persons who are the initial trustees of the corporation remain the same as located in the attachments

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate or public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (C) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or by a corporation contributions to which are deductible under section 170 (C) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.
