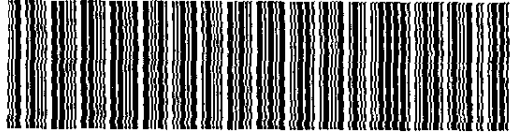

## **ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator (s) of a corporation  
Pursuant to chapter 617, Florida Statutes, adopt (s) the following  
Articles of Incorporation.

### **ARTICLE ONE NAME**

The name of the incorporation shall be:

### **ARTICLE TWO PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and mailing address of this corporation shall be:

### **ARTICLE THREE DURATION**

The period of duration of this nonprofit corporation shall be perpetual.

### **ARTICLE FOUR PURPOSE (S)**

The specific purpose (s) for which this corporation is organized are exclusively religious and charitable, within the meaning of Section 501 © 3 of the Internal Revenue Code of 1986 or the Corresponding provision of any future United States Internal Revenue law.

This Corporation is Non-for-Profit Corporation and is not organized for the private gain of any person. It is organized under the nonprofit Public Benefit Corporation Law for charitable purposes.

1. To proclaim **JESUS** as our Lord and Savior and the only path to **LIFE!**
2. To proclaim that **LIFE** is only found through **Living In Faith Everyday!**

3. To proclaim this message of **LIFE** through the action of **LOVE** by reaching out to the Helpless, Hopeless and Homeless 24 hours a day, 7 days a week.
4. To offer 24 hours a day, 7 days a week Emergency Assistance to the Helpless, Hopeless and Homeless of Broward County through the activation of a toll free hotline, 1- ??? – **LIFE911**.
5. To open and operate a 24 hours a day, 7 days a week **LIFE911** Emergency Assistance call center that will employ operators to answer the phones and assist those seeking help.
6. To develop a **LIFE911** website, [www.LIFE911.org](http://www.LIFE911.org) that will link all the Christian churches, ministries and service providers together to assist operators in locating solutions to those seeking help and to serve as an online Emergency Assistance Center.
7. To acquire a building to open a Emergency Assistance **LIFE911** Center that will provide emergency assistance to include food, clothing, daycare, counseling, medical, dental, etc. This center would be open 24 hours a day, 7 days a week and offer a FREE King's Buffet to the Helpless, Hopeless and Homeless.
8. To develop a **LIFE911** TV program that will broadcast a one hour show that will feature local needs, opportunities and success stories within our community.
9. To develop and publish a monthly **LIFE911** Newsletter that would be distributed throughout the local Christian churches to enlighten, inform and educate our community of our efforts.
10. To create ongoing **LIFE911** fundraising events and entertainment opportunities to include a golf tournaments, Sunday brunches, youth concerts, etc in an effort to raise public awareness and to assist in raising the necessary operational funds.
11. To develop a weekly **LIFE911** Saturday BBQ Outreach to the Helpless, Hopeless and Homeless where Solutions can immediately be brought into peoples lives to include Free Medical, Free Dental, Free **LIFE** Planning, and **LINKS** to local solutions for any and all seeking help of any kind.
12. To develop a **LIFE911** Radio / Talk Show call in program that serves as an outreach to the Helpless, Hopeless and Homeless by providing immediate solutions to those seeking help.
13. To develop a **LIFE911** Documentary that will highlight the Helpless, Hopeless, and Homeless in Broward County to serve as an awareness tool for those who are seeking to help us help others.

## **ARTICLE FIVE NON STOCK CORPORATION**

The corporation shall be non-stock and no dividends or pecuniary profits shall be declared or paid to the members thereof.

## **ARTICLE SIX DIRECTORS**

The initial Board of Directors will consist of three (3) directors. The number of directors may be increased or decreased as stated in the By-Laws, but shall in no case be less than three (3). The names and addresses of the persons who are to serve as initial directors are as follows:

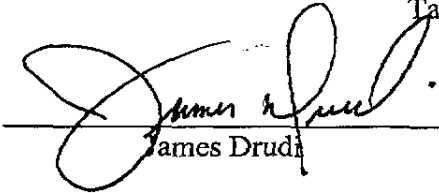

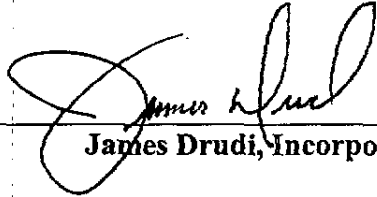
**ARTICLE TWELVE
