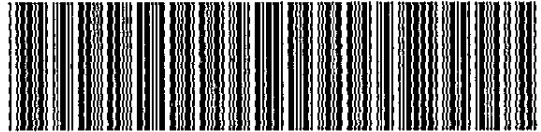



**ARTICLES OF INCORPORATION
of
INHERITING THE KINGDOM MINISTRIES, INC.
A Non-Profit Corporation**

The undersigned subscribers of these Articles of Incorporation, being natural persons competent to contract, hereby subscribe to and form a corporation not for profit under the laws of the State of Florida.

**ARTICLE I
Name and Principal Office**

The name of the corporation is Inheriting the Kingdom Ministries, Inc., a Non-Profit Corporation, and it shall have as its principal address is 344 Katrina Street, DeLeon Springs, FL 32130 and mailing address is P. O. Box 442, DeLeon Springs, FL 32130.

**ARTICLE II
Duration**

The corporation is to exist perpetually, with commencement at the time of filing these Articles.

**ARTICLE III
Purpose**

The purpose or purposes for which the corporation is organized are:

1. To present live Christian stage musicals wholly based upon biblical teachings and principles and to provide materials and classes in local churches to enable such churches to present their own Christian programs.
2. To do such other things that are incidental to the foregoing or necessary or desirable to accomplish the foregoing.
3. Further, the corporation is exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

4. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

ARTICLE IV **Qualification**

Any person eighteen (18) years of age and over, evidencing a willingness to work toward the goals of the organization, may be accepted to regular membership on approval of the Board of Directors.

ARTICLE V **Registered Agent and Address of Registered Office**

The name of the initial registered agent of the corporation is Barbara Vu and the street address of the initial registered office of the corporation is 344 Katrina Street, DeLeon Springs, FL 32130.

ARTICLE VI **Directors**

The initial number of members constituting the initial Board of Directors shall be five (5), and the names and addresses of the persons who are to serve as the initial directors are:

The number of members may be changed by the directors, not less than three (3), and the method by which the directors shall be appointed or elected in the future will be stated in the Bylaws of the corporation.

ARTICLE VIII

This corporation is organized under a non-stock basis.

Dissolution

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954, or as amended in 1986 or otherwise, or corresponding sections of any future law, or to the Federal, State or local government for exclusive public purpose.

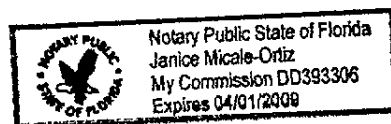
