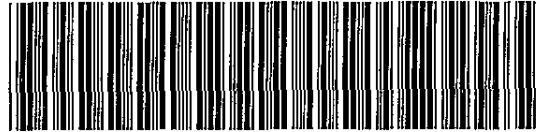

ARTICLE ONE

Name

The name of the Corporation is Life Changing Community Christian Church, Inc.

ARTICLE TWO

Principal Office and Address

The address of the principal office and mailing address of the corporation is 6504 Iosa Drive, Jacksonville, Florida 32277.

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE FOUR

Purpose

The specific and primary purpose of this body shall be that of a religious and charitable organization established and maintained, not for profit, but to disseminate the Gospel of Jesus Christ and perform charitable work for the good of humanity.

The general powers are:

1. To purchase, lease, or otherwise acquire, improve, construct, own, hold, use, maintain, operate, exchange, encumber, sell, convey, or otherwise dispose of, real and personal property of every kind, nature, or description, as may be necessary or desirable to promote the primary purpose of this corporation.

2. To make and perform contracts of every kind for any lawful purpose without limit as to amount, with any person, firm, association, corporation

3. To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of this corporation.

4. To have and exercise all the rights and powers conferred on nonprofit corporations under Florida law, as such law is now in effect or may be from time to time amended.

5. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal revenue Code or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the circuit court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as the Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE FIVE

Directors

The method of election of the directors of the Corporation is set forth in the bylaws.

ARTICLE SIX

QUALIFICATION OF MEMBERS

The membership of this corporation shall consist of all persons whose names appear in the membership rolls of this corporation on the date of this filing and such persons as, from time to time hereafter, may be or become members, in the manner provided by the bylaws.

ARTICLE SEVEN

NONPROFIT TAX-EXEMPT STATUS

This corporation shall not engage in any activity which is prohibited by corporations

exempt from federal income taxes under Section 501(c)(3) of the Internal revenue Code.

ARTICLE EIGHT

PRINCIPLES

This corporation shall confer on the office of Pastor(s), and any teaching position within the corporation only upon those pastors, teachers, or other candidates who are qualified for their work in the manner provided for in the bylaws.

ARTICLE NINE

REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation shall be located at 1400 Prudential Drive, Suite 1, Jacksonville, Florida 32202. The initial registered agent of the Corporation at that address shall be Ronald R. Austin, Esquire.

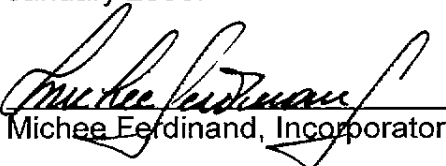
