Articles of Amendment to Articles of Incorporation of W.G. KINGS PROPERTY OWNERS ASSOCIATION, INC.

The W.G. Kings Property Owners Association, Inc.'s Articles of Incorporation are hereby amended as follows:

Article III of the Articles of Incorporation are hereby replaced in its entirety with the following:

ARTICLE III

Dissolution

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.047, F.A.C., and be approved in writing by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

Existence and Duration

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.
