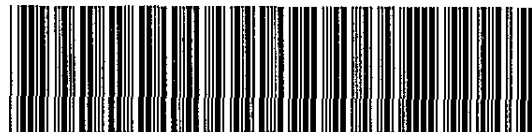



TWO: This corporation is a nonprofit mutual benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, Educational and Charitable purposes to aid the poor and disadvantaged youth and families towards a life of self-sufficiency. To establish structured support service for outreach to the community. The programs will consist of but shall not be limited to: Mentoring, Designing, Real Estate, Catering, Outings, and other programs to aid those who are in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


