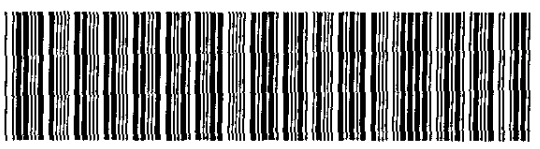

ARTICLE I. - NAME

The name of the corporation is Florida Stop Lawsuit Abuse, Inc.

ARTICLE II. - PRINCIPAL OFFICE

ARTICLE III. - PURPOSE

The specific and primary purpose for which this corporation is organized is to promote the mutual benefit of Floridians by educating citizens on the negative effects of lawsuit abuse.

ARTICLE IV. - MANNER OF ELECTION

The manner in which the directors are elected or appointed:

At the organizational meeting, the Incorporator named in the Articles of Incorporation shall designate three (3) Directors of the Board and the initial terms of office of the Directors. Thereafter, at each annual meeting of the Board of Directors, a number of Directors equal to that of those whose terms have expired shall be elected for a term of four years. Such election shall be by a majority of the Directors whose terms have not expired and who are present and voting. Any Director may be reelected at the expiration of his term of office.

ARTICLE VIII. - DISSOLUTION

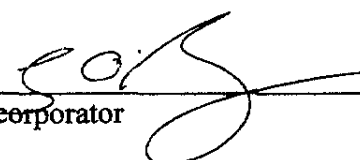
