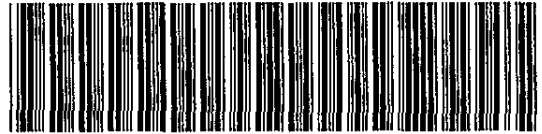

**ARTICLE I                      NAME**

The name of the corporation shall be New Age Seer, Inc.

**ARTICLE II      PRINCIPAL OFFICE**
