Name

The name of the corporation shall be Jefferson Landing E.A.A. Chapter 1427, Inc.

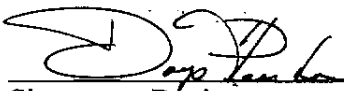
**Article VIII

Dissolution**

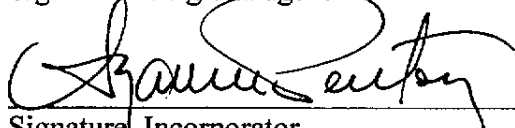
