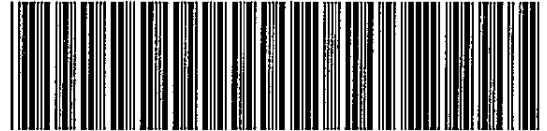

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: PET FLORIDA-JAX, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 2253 Oxbow Road
Jacksonville, Florida 32210

The mailing address shall be: 4341 Savannah Avenue
Jacksonville, Florida 32210

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Section 1 The Corporation is organized and operated for the following general purpose: exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law, including for such purposes, the making of distributions to organizations which are recognized as exempt from tax under such 501(c)(3).

Section 2 To produce a "P.E.T." A "P.E.T." is a three wheel, hand pedaled wheelchair that can go where wheelchairs cannot go. P.E.T. is an acronym for Personal Energy Transporation.

Section 3 To provide a FREE GIFT OF MOBILITY in the form of an adult or a child size PET for people living in poverty in economically developing societies who have lost the use of their legs to land mines, disease, or accidents and who live in areas where a normal wheelchair cannot function.

Section 4 To provide meaningful volunteer opportunities for retirees and other interested persons in the more affluent western world in the funding, manufacture, and distribution of PETs.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed: The Directors are elected by the Board in accordance with the Bylaws.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

ARTICLE VIII TERMINATION OR DISSOLUTION

The property of the Corporation is hereby irrevocably dedicated to religious and charitable purposes. Upon dissolution of the Corporation, the Board of Directors shall,

after paying or making provisions for the payments of liabilities of the Corporation, dispose of all the assets of the Corporation as follows, provided such organization qualifies as an exempt organization under Section 502(c)(3) of the U.S. Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

- a) First, to PET International, Inc. for use of and by other PET affiliates;
- b) If PET International and/or other PET organizations shall cease to exist or fail to qualify as an exempt organization as described herein, to such other qualified tax exempt organization or organizations, as described herein, that the Board of Directors shall choose.
