

## ARTICLES OF INCORPORATION OF

#### CAMDEN VILLA I CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

#### ARTICLE I.

The name of this corporation is CAMDEN VILLA I CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 7160 David Boulevard, Port Charlotte, FL 33981, and the mailing address of the corporation is 7160 David Boulevard, Port Charlotte, FL 33981.

#### ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed CAMDEN VILLA I CONDOMINIUM ASSOCIATION, INC., a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

#### ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of CAMDEN VILLA I CONDOMINIUM ASSOCIATION, INC., a Condominium.

#### ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: Any person or persons who hold title in fee simple to a condominium unit in CAMDEN VILLA I CONDOMINIUM ASSOCIATION, INC., a Condominium, shall by virtue of such ownership be a member of this corporation.

#### ARTICLE V.

This corporation shall exist perpetually.
