ARTICLES OF INCORPORATION

Of

Fellowship of S.E. Florida Baptist Churches, Inc.

The undersigned, acting as Incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

ARTICLE ONE - NAME AND MAILING ADDRESS

The name of the Corporation shall be:

FELLOWSHIP OF S.E. FLORIDA BAPTIST CHURCHES, INC.

The mailing address of the corporation shall be:

18401 NE 21 Place, North Miami Beach, FL 33179

ARTICLE TWO - PURPOSE

SECTION 1 - To provide the churches means for harmonious action in support of pastors, churches and their desire to work together in mission and evangelistic causes.

SECTION 2 - To exercise the authority to own, receive, hold, administer, sell or otherwise dispose of assets: real, personal, tangible and intangible.

SECTION 3 - The Corporation is a tax-exempt religious entity under the laws of the United States of America and the State of Florida.

ARTICLE THREE - MEMBERSHIP

SECTION 1 - The Corporation consists of member churches who have voluntarily joined together for cooperative fellowship and effort.

SECTION 2 - Churches may be admitted by unanimous vote of the Credentials Committee.

SECTION 3 - Churches are required to support the Corporation thru Prayer, Participation and Finances.

SECTION 4 - Churches may be represented by their senior Pastor and four messengers duly elected by the church at the Corporation's Annual Meetings.

ARTICLE FOUR - MANAGEMENT OF CORPORATION

The affairs of the Corporation shall be conducted and managed by the Board of Directors. The initial directors shall be appointed by the Incorporators.

The method of election or appointment of future Directors shall be stated in the Bylaws.

The Board of Directors shall create committees as needed and shall define purpose, term and members in the Bylaws.

The Board of Directors shall elect Officers for purposes of signing legal documents including checks. The initial officers shall be the incorporators in order as listed in Article Six, President, Vice-President and Secretary.
