The number of directors in office was 5 and the vote for resolution was 4 for and 1 against.

Plan of Distribution of Assets Fushu Daiko, Inc.

Fushu Daiko Inc, a Florida not-for-profit-corporation, has filed an amendment for dissolution to its articles of incorporation and the following is a plan of the division of the corporation's assets as agreed upon by a majority of the sitting board of directors as there and supported by the non-voting members of Fushu Daiko.

The Board of Directors certifies that:


- a) There are no liabilities or obligations of the corporation left to be paid or discharged;
- b) There are no assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, be returned, transferred, or conveyed in accordance with such requirements;
- (c) The only assets that remain for distribution are instruments and equipment for the performance of taiko drumming. These will be distributed as follows:
- 1) To Fernando Moraes, Sincronia USA:
 - 4 small okedo purchased in Brazil
 - 2 large okedo purchased in Brazil
 - 4 shime daiko in bags, purchased in Brazil
 - 4 miya daiko purchased in Brazil
 - 1 miya daiko purchased in the US (Clarion)
 - 2 hira daiko, approx. 45" diam. heads, rope tuned,
 - Large aluminum gong stand
 - 1 gong
 - 2 folding slant stands
 - All merchandise purchased for the purpose of sale to the public
 - All equipment bags (for drum transportation, protection, and storage).

These assets equal more than 1/5th of the corporation's assets and were distributed to Mr. Moraes in an act of generosity and kindness on the part of the directors and members of Fushu Daiko in order to provide an opportunity for him to continue the activities of a taiko group under a different performing name and under a different corporation if he so wishes.

- 2) To the remaining 4 Directors and the 7 other Members of the performing group known as "Fushu Daiko":
 - All Fushu Daiko performing equipment pre-dating Mr Moraes' involvement with the performing group known as "Fushu Daiko" and/or his involvement with its corporation named Fushu Daiko, Inc.

- Large okedo known as "plumpy"

- 2 miya daiko refered to as "Chinese" 2 miya daiko refered to as "the blond drums"
- taiko related hand percussion, conchs, & various idiophones

These assets will be distributed to the members of the performing group known as Fushu Daiko in order to continue to operate under a new corporation without the involvement of Fernando Moraes or his corporation, Sincronia USA.

The aforementioned lists consist of the entirety of the known assets of Fushu Daiko, Inc. and this distribution will be the last act of Fushu Daiko, Inc., doc # N06000001737.
