# Articles of Amendment to Articles of Incorporation of Bay Community School of Apalachicola, Inc.

### **Article III Purposes**

Article III is amended to reflect IRS code description pertaining to our tax exempt purpose and Article III is hereby replaced in its entirety by the following:

#### Article III

The purposes for which Bay Community School of Apalachicola, Inc. was organized is to provide a safe, loving environment where early social, emotional, physical and cognitive development skills can develop with center based pre-school education and learning activities for children.

This organization is organized exclusively for charitable, educational purposes under <u>Section 501 (c) (3)</u> of the Internal Revenue Code, or corresponding section of any future federal tax code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publication or distribution of statements) on behalf of any candidate for public office. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by and organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Article VIII

Article VIII is being added to reflect required language per IRS code:

### Article VIII

This corporation is organized pursuant to the corporation's not for profit law in the State of Florida. This corporation does not contemplate pecuniary gain or profit to the director's thereof, and it is organized for non-profit purposes.

In the event of dissolution, the assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a non –profit fund, foundation or corporation which is organized and operated exclusively for purposes under Section 501 (c) (3) of the Internal Revenue Code and which has established its tax-exempt status under Chapter 617, Florida Statutes.
