ARTICLE III PURPOSE

The Mt. Zion Christian Methodist Episcopal Church exists under the authority and discipline of the Holy Spirit and the *Discipline* of the Christian Methodist Episcopal Church as from time to time enacted, authorized and declared by the General Conference. No By-laws shall be adopted inconsistent with the provision of the *Discipline*. The purpose of the Mt. Zion Christian Methodist Episcopal Church is the following:.

- a. The maintenance of Christian worship, fellowship and discipline, the nurture and building up in the faith of believers, the conversion of sinners and the world, and for witnessing so that societal structures may become just in order that the personhood of all peoples may be more fully realized according to the image of God in human beings. The church exists in and for the world. The believers move from formal worship of God into the world where worship is witnessing through service to human beings.
- b. Acquiring, owning, and maintaining real estate, buildings and other property, both real and personal, subject to the laws, usages, ministerial appointments of the Christian Methodist Episcopal Church as are now or shall from time to time established, made and declared by the lawful authority of said Church.
- c. Doing of any and all things necessary or incident to the accomplishment of such purposes.
- d. All of the above shall be in accordance with the Doctrine, Laws, Usages, Discipline, and pastoral appointments of the Christian Methodist Episcopal Church.
