

ARTICLES OF INCORPORATION OF AMBER CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is AMBER CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 109 Taylor Street - Suite 112, Punta Gorda, Florida 33950, and the initial mailing address of the corporation is 1683 Manor Road, Englewood, Florida 34223.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed AMBER CONDOMINIUM, located in Charlotte County, Florida, and to operate property owned by the Association.

ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of AMBER CONDOMINIUM.

ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: Any record owner of legal title to a condominium unit in AMBER CONDOMINIUM, shall by virtue of such ownership be a member of this corporation.

ARTICLE V.

This corporation shall exist perpetually. In the event, however, this Association is dissolved, the control or right of access to the property or common elements of the Condominium containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if not accepted, then the surface water management system facilities shall be conveyed to a not-for-profit corporation similar to the Association.

The affairs of the corporation are to be managed by a Board of Directors, the number of members of which shall be as provided in the Bylaws provided that there shall be not fewer than three and not more than seven. The Directors will be elected each year at the annual meeting of the Condominium Association as provided for in the Bylaws, subject to the rights of the Developer and unit owners to elect directors as provided in Section 718.301, Florida Statutes (2005), and in the AMBER CONDOMINIUM Declaration.
