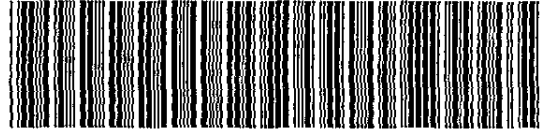

**ARTICLE VIII: EFFECTIVE DATE**


