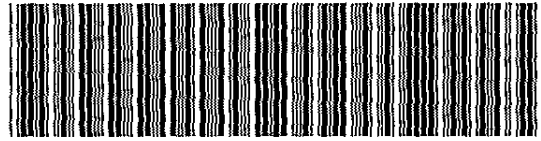

ARTICLES OF INCORPORATION  
In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I**

The name of the corporation shall be :

“TEMPLE TERRACE GARDEN CLUB, INC.”

**ARTICLE II**

The Principal place of business and mailing address of this corporation shall be:

Temple Terrace, FL 33617

**ARTICLE III**

This corporation is organized to provide fundraising activities:

1. To contribute to the promotion of gardening and to encourage the growing of plants and trees in private and public areas of the City of Temple Terrace.
2. To further the education of garden club members and the public in horticulture, floral design and environmental concerns.
3. To cooperate with other organizations in the Temple Terrace area in matters of mutual concern.

No part of the net earnings of the organization shall be used for the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions to further the purposes set forth in the purpose clause above.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or publish statements on behalf of any political campaign or on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding

section of any future federal code, or by an organization, contributions to which are deductible under section 170© (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV**

The President and all officers are elected each year by its membership according to the bylaws of the organization. Terms of the office indicate that officers may serve for one or two years and no members shall be eligible for the same office for more that two consecutive years, with the exception of the treasurer. If vacancies should occur in the office of president the first Vice President shall become President. A new First Vice President shall be elected by the membership at the meeting after the vacancy occurs. Any other vacancy shall be filled by a majority vote of the Board of Directors. The board of directors are composed of the elected officers, the immediate Past-President, Parliamentarian, and the Chairpersons of Standing Committees.

## ARTICLE IX

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) or the Internal Revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
