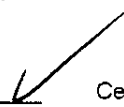



This is not a joint stock company and there shall be no capital stock. Membership shall consist of members of the unincorporated Women of Promise Ministry Incorporate as shown on the existing ministry roll on the date these Amended articles of incorporation are filed in the office of the Secretary.

Membership thereafter shall be acquired by confirmation by the existing ministry, by confession of faith, all such admissions, however, being in accordance with the constitution and By-Laws adopted by the membership shall be terminated by death, withdrawal, or other reasons as specified in Article IV of the constitution. 
Amend Article IX The annual election and business meeting of the corporation shall be held on the first Saturday in December.
