ARTICLES OF INCORPORATION

OF

TOUGH LOVE PROGRAM, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby arts as an orator in adopting and filing the following articles of incorporation for the purposes of incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Not for Profit corporation under the Not for Profit Corporation Law of Florida.

ARTICLE I

The name of the Corporation is: Tough Love Program, Inc.

ARTICLE II

ARTICLE III

The purpose for which this corporation is organized is exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purpose of this corporation is to carry out its mission of promoting faith based service networks to provide treatment and recovery support services to substance abusers in communities that are at risk of suffering these behaviors.

ARTICLE IV

The manner in which the directors are elected/appointed:

The member shareholders shall nominate and elect the directors and officers.

ARTICLE V

The initial street address of the Corporation's registered office is: 5327 SE Graham Street. Stuart, Florida, 34997. The initial registered agent for the Corporation at that address is: Deanna Smith.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding

section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
