

Enclosed for filing please find the Articles of Dissolution for Friends of the Fleet and Family Support, Inc., a Florida Nonprofit Corporation.

The Dissolution Plan adopted by the Corporation addresses distribution of all remaining assets of the Corporation and has been prepared in accordance with the provisions of Section 617.1406, Florida Statutes. Approval is hereby requested from the Department of State of the Dissolution Plan and of the proposed dissolution of the Corporation.

As is further required by the relevant provisions of Chapter 617, Florida Statutes, the Corporation's Dissolution Plan was approved by the Board of Directors of the Corporation on January 11, 2008. Dianne E. Parker, President and Chair of the Board of Directors of the Corporation, has authenticated the copy of the Dissolution Plan that is enclosed and certifies that the necessary approval procedure set forth in Section 617.1406(2), Florida Statutes, was followed by the Board of Directors in adopting the Dissolution Plan.

As required by Section 617.1406, Florida Statutes, the Dissolution Plan approved by the Board of Directors of Friends of the Fleet and Family Support Center, Inc., provides for the payment and discharge of all liabilities and obligations of the Corporation; the disposition of all assets (if any) that are held under contractual or other conditions for return, transfer, or conveyance in the event of dissolution of the Corporation in accordance with those conditions; for the disposition of assets that are received and held for use only for "charitable, religious, eleemosynary, benevolent, education, or similar purposes" to one or

more domestic organization engaged in activities that further those purposes to recipients that are engaged in activities substantially similar to those of the Corporation; for the distribution of other assets (if any) in accordance with the Articles of Incorporation of the Corporation to the extent that they contain specific distribution provisions; and, for the distribution of any remaining assets (if any) to such other persons or organizations in accordance with the Articles of Incorporation of the Corporation.

A check in the total amount of \$43.75, consisting of the fee of \$35.00 for the filing of the Articles of Dissolution and of the fee of \$8.75 for a certified copy of the filed Articles of Dissolution, is also enclosed. Please return the certified copy of the proof of filing of said Articles of Dissolution to the undersigned.
