**ARTICLES OF INCORPORATION
OF
PSYMORE RESEARCH INSTITUTE, INC.**
A Florida Not for Profit Corporation

The PsyMore Research Institute, Inc. shall be a nonprofit corporation located in Hillsborough County, Florida in compliance with Chapter 617 under the Florida Not For Profit Corporation Act as described herein in these Articles of Incorporation.

ARTICLE I (Name)

The name of the nonprofit corporation shall be: PsyMore Research Institute, Inc.

ARTICLE II (Principle Office)

Principle Office: 15622 Bear Creek Drive, Tampa, Florida 33624.

Mailing Address: P. O. Box 340464, Tampa, Florida 33694

ARTICLE III (Purpose)

The organization is structured for literary, scientific, and educational purposes that may benefit the knowledge and understanding of the human potential and sustainability concerns within the meaning of the Internal Revenue Code 501(c)(3) and for the corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

The mission of PsyMore Research Institute, Inc. shall be to facilitate the pioneering and visionary expression of scientific inquiry that furthers the practical application of knowledge for the betterment of humankind, the environment, and sustainability of all life. As funds may allow, PsyMore Research Institute, Inc. shall:

- A. Conduct domestic and/or international multi-cultural research.
- B. Be involved in workshops and/or conferences to disseminate the findings of research conducted and/or disseminate findings from other scientific sources.
- C. Serve as a pass-through agency for researchers that desire to conduct research independent of their educational, organizational, and/or other affiliations.
- D. Conduct research from a broad or specific focus involving community and/or global interests and/or needs.
- E. Provide a forum to encourage independent scientific research and praxis.
- F. Develop literary materials in varied formats to disseminate the knowledge and understanding of scientific inquiry and findings to a broad or specific population.

The corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under the Internal Revenue Code 501(c)(3) of 1968, as amended (or the corresponding provision of any future United States Internal Revenue law). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or

intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code of 1968, as amended.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended or supplemented, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation will be then located, exclusively for such purposes or to such organization or organizations, as said Court Shall determine, which are organized and operated exclusively for such purposes. Furthermore, no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the corporation and to make payments and distributions in furtherance of the purposes set forth herein.

ARTICLE IV (Directors Manner of Appointment)

Elections for Board members shall be held at the Annual Meeting of the Board of Directors. The Board of Directors may appoint interim Directors deemed appropriate as governed by the Bylaws to serve until the Annual Meeting. Directors shall serve continuously until their removal, resignation, or other attrition as governed by the Bylaws.


