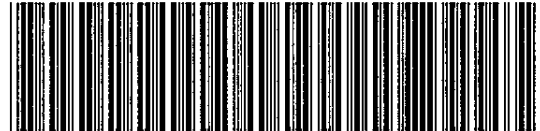

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I - NAME:

The name of the corporation shall be:

Gobierno Provisional y Paralela de la Republica de Cuba Inc.

ARTICLE II - PRINCIPLE OFFICE:

The principle office of business and mailing address of this corporation shall be:

10420 SW 58 St., Miami, FL 33175

ARTICLE III - PURPOSE:

This organization would like to work towards establishing a provisional and parallel government in the Republic of Cuba as under in the constitution in 1940.

ARTICLE IV - MANNER OF ELECTION:

The manner in which the directors are elected or appointed will be stated in the by-laws.

ARTICLE V PROPOSAL

1. Categorically: the illegality of Castro's regime:
2. We are working towards the formation of a Provisional Government whereby its main purpose is to establish a legal system in Cuba;
3. The provision: based on a General Assembly that should appoint the Executive Delegates.
4. The formation of a Sovereign General Assembly: by the vote of the Cuban people on the island and the exiles abroad based on the Martiano principle of with everyone and for the good of all the Cubans (liberty of press, etc.);
5. That the votes are validated by representatives of the Civil Society in the island, and also by exiles abroad through patriotic Cuban organizations, representatives of human rights organizations such as the United Nations, International Amnesty, American Watch and others.
6. Obtain the recognition of a Provional Government on the part of friendly countries (as did the Father of our Country, Carlos Manuel de Cespedes, 1868) and as other countries have responded positively such as Peru, Ecuador, Chile and Colombia among others.
7. The headquarters of the Provisional Government - if it could not be here, in the free zone of Guantanamo or in any other place on the rest of the island - it would remain temporarily in the friendly country that responds positively to the Cuban people's Patriotic call.




